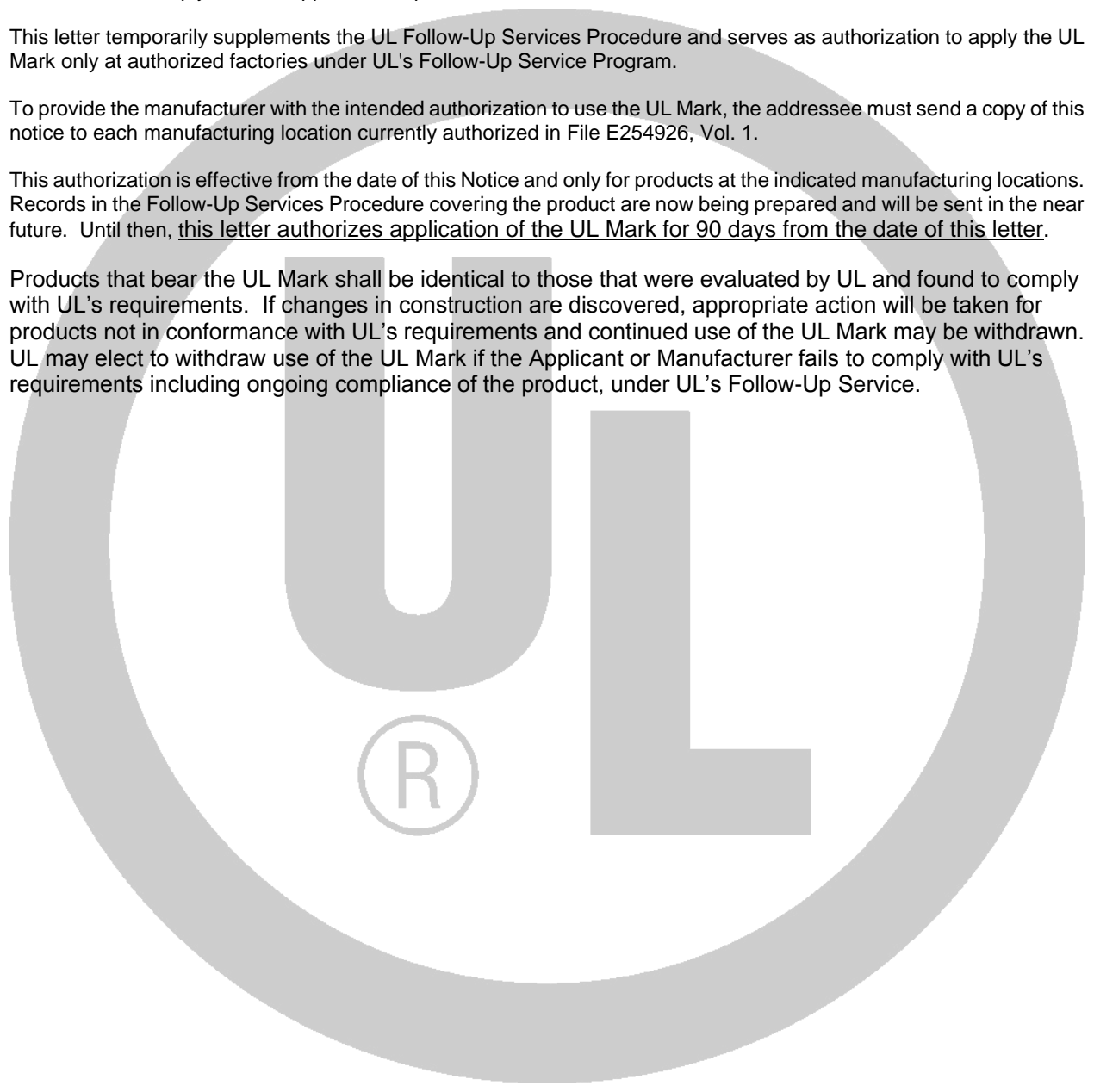
UL's investigation of your product(s) has been completed under the above Reference Number and the product was determined to comply with the applicable requirements.
